Liability Release and Waiver of Claims

I, _____, acknowledge that I am engaging the services of Healing in Color Bodywork, hereinafter referred to as the "Professional," for the purpose of equine bodywork and related services. In consideration of the services provided by the Professional, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I agree to the following terms and conditions:

1. Assumption of Risk:

I am fully aware that equine bodywork involves inherent risks and dangers, including but not limited to the unpredictability of horses, the potential for sudden movements or reactions, and the possibility of injury to the horse or to me. I voluntarily assume all risks associated with the services provided by the Professional.

2. Release and Waiver:

I hereby release, discharge, and hold harmless the Professional, their agents, employees, contractors, and assigns, from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury, or harm, including but not limited to personal injury or property damage, that may be sustained by me, my horse, or any other individual as a result of the services provided by the Professional.

3. Limitation of Liability:

I understand and acknowledge that the Professional has made no warranties or representations regarding the outcome of the equine bodywork services provided. The Professional shall not be liable for any direct, indirect, incidental, special, or consequential damages arising out of or in any way connected with the services provided, regardless of the cause of action or legal theory.

4. Voluntary Participation and Responsibility:

I affirm that I am participating voluntarily and have disclosed any relevant medical conditions or concerns regarding the horse to the Professional. I agree to follow all instructions provided by the Professional during the course of the equine bodywork session.

5. Indemnification:

I agree to indemnify and hold the Professional harmless from and against any and all claims, actions, damages, liabilities, costs, and expenses, including reasonable attorney's fees, arising out of or resulting from my participation in the equine bodywork services or any breach of this agreement.

6. Severability:

If any provision of this agreement is found to be unenforceable or invalid, the remaining provisions shall remain in full force and effect.
